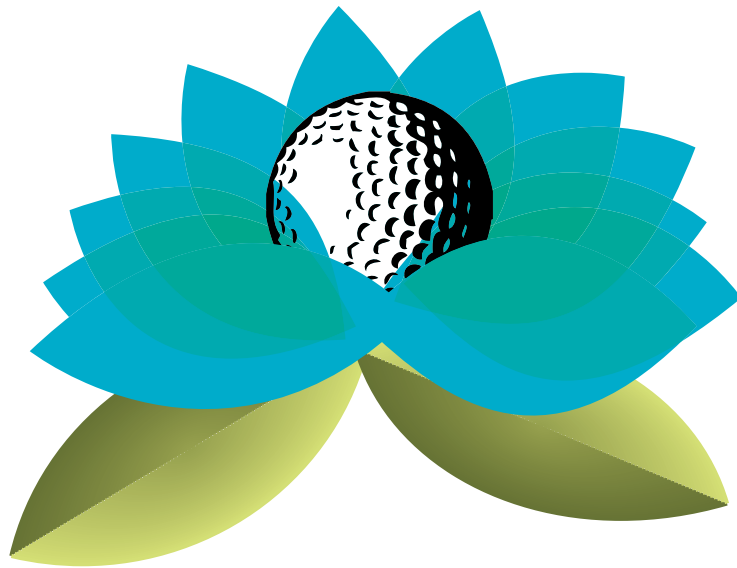

Though this is the first attempt to raise funds for Calanthe, I certainly hope it will not be the last. Your response to this call will go a long way in making that determination.

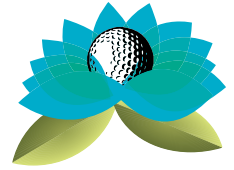

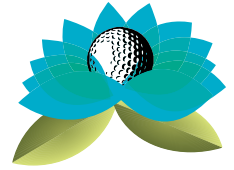

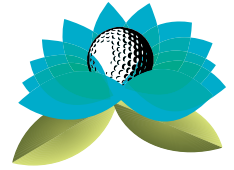
